# Pepper Institute on Aging and Public Policy 2010-2011 Annual Report September 2011

#### Overview

The 2010-11 academic year in the Pepper Institute was characterized by successes in publications and grant activities, the facilities, public service, and outreach.

#### 1. Support of research and grant activity

\_Associates of the Pepper Institute actively published and were awarded external contracts and grants during the 2010-11 academic year. Many of the associates' publications appear in top journals of their respective fields. Their research was recognized by honors such as John Reynolds' 2010 best paper award from the Sociology of Mental Health Section of the American Sociological Association and Jill Quadagno's appointment to the Institute of Medicine for her scholarship on aging, health and social policy issues. The Institute was also awarded a grant from the Florida Department of Transportation aimed at improving the safety of seniors on Florida's roads.



# 2. Facilities

### 3. Public face

Lectures: Ken Brummel-Smith presented invited lectures for the Florida Association of Homes and Services for the Aging, Florida Academy of Family Physicians, University of Kentucky, UCLA, and at John F. Kennedy Hospital in Boca.

<u>Awards and Appointments</u>: The Institute of Medicine, a prestigious national organization, elected Jill Quadagno as a member for her work on aging, health and social policy issues. Dr. Quadagno also received a University Distinguished Graduate Teaching Award and the Graduate Mentor Award from the Department of Sociology Graduate Student Union.

Intellectual Environment: The Pepper Institute and Department of Sociology jointly brought in two guest speakers this year as part of the Pepper Institute Spring Lecture Series. Dr. Kyriakos Markides from The University of Texas Medical Branch gave a talk titled, "Aging and Health among Hispanics/ Latinos in the United States." Dr. Kenneth Ferraro from Purdue's Center on Aging and the Life Course presented "Enduring Effects of Early Adversity on Adult Health." Both lectures were well attended.

# 4. Outreach

<u>OLLI at FSU</u>: The primary outreach activities supported by the Pepper Institute consist of the classes, lectures, and other gatherings of the Osher Lifelong Learning Institute of FSU. In the past year, OLLI offered 34 classes ranging in topic from art, literature, classical music, nutrition and science. Various speakers, including current and former FSU and FAMU Presidents, presented lectures to OLLI members. OLLI members also took cultural trips to Jacksonville, Gainesville, and Savannah, as well as local excursions to Tallahassee museums, parks and art events.

Membership grew to 509 this year, up 383 from the previous year, making OLLI at FSU eligible for a one million dollar endowment from the Bernard Osher Foundation. Director Cory Livingston submitted the endowment proposal in August and is waiting on a final decision from the national OLLI organization.
